One and All:

First. In the initial blast to all users, I received zero ConnectUs feedbacks. I initially thought it must have been perfect. WOW! However, it turns out that ConnectUs didn't work. Darn! That has now been fixed. So, "feedback away."

Second. There is now a button on the UseSupport page that displays two download inventory reports.

The first download inventory report presents the quantity of downloads for each item type that can be downloaded. The second download inventory report presents the quantity of pages/slides for each of the specific Training Courses and Tech Papers. This set of inventories is updated and published whenever changes (more downloads, not fewer), are posted to the WhitemarshUltraTree website.

Third. The download links for downloading screen shots and execution demos can be downloaded by everyone.

Fourth. The download links for downloading screen shots and **execution-based** demos for **Active Support Users** can be downloaded. So too can the Clarion Source code (app, dct, etc.) for these Demos. And finally, the Installers can be downloaded. **WARNING**: the Clarion Source, and Installers are NOW being updated. There is a warning note to that effect. Soon, those NOTES will be removed when these files are updated and validated.

Fifth. WhitemarshUltratree Development Workplan:

- **Plan Item One**: Creating **Teaching pdfs** for each and every Clarion Demo that identifies both the demo rationale and the detailed steps of what was done to accomplish the results. I remember well how much "fun (NOT!)" it was to deploy UltraTree back in 1995.
- **Plan Item Two**: Via the Whitemarsh Data Models diagrams for the Metabase System, every Single File Recursion and Bill of Materials will be shown so that you can get an idea of why these two UltraTree LX templates can/should be used. If you have other similar diagrams, send them to me and they will be posted.
- Plan Item Three: Several years ago a "generalized" set of Clarion code was created that enables a very quick creation of both Single File recursions and Bill of Materials. This generalized set of code enabled a standardized deployment for each and the mapping of the particularized tables and variables to the generalized variables. This strategy enable me to deploy each in half the time formerly required. There will be a "User Guide" for this.
- Plan Item Four: Clarion-based Application Assists. These will be two that are based on UltraTree BOM-based analyses: DCT (via a DCTX) and App (via a TXA). These provide views into both for large databases and applications. The user guides for these will be illustrated via the Metabase System's DCT (about 500 tables) and Apps (about 20).
- **Plan Item Five:** There are three Metabase System functional modules that will be extracted from the Metabase System.
 - Five.1 Project Management. This is not based on tasks completed, but on deliverables produced. The Project Management is set within a Work Breakdown structure that has been developed and

honed over many years.

- ♦ Five.2 Database Migration (extended to include TPS). This is a reimplementation and extension of "JP's" software that was created years ago. It disappeared with JP died.
- ♦ **Five.3 Requirements Management.** This enables creation, capture, and allocation of requirements to be addressed during data-based business information system projects.

Sixth: Whitemarsh Application Release. I have created a number of Clarion-based applications. Some small, some medium and some large. All SQL-based. The list follows. All these will be updated, documented, and released in "Clarion form" for you to download build, modify, for yourself or for others.
